## Waterson Terminal Services enters Green Marine environmental certification program

**Providence, RI, December 18, 2018** – Waterson Terminal Services is joining Green Marine environmental certification program for its stevedoring and terminal operations at ProvPort. Green Marine is a leading North American environmental certification program for the maritime transportation industry. The program is a voluntary initiative to surpass regulatory requirements within the maritime industry.

Waterson is the first terminal operator from Rhode Island to join Green Marine's environmental certification program. There are currently more than 125 companies including ship owners, port authorities, terminal operators and shipyard managers from coast to coast in Canada and the United States participating in the certification program.

"We are always looking for ways to improve our operations and joining a well-recognized sustainability program such as Green Marine will allow us to exceed environmental standards," said Waterson Terminal Services General Manager Christopher Waterson. "The clear criteria beyond current regulations will help guide our actions towards continually improving our environmental performance."
